To apply for a Personal Information Card you must complete this form and provide the relevant evidence of identity documents to a Service Tasmania Customer Service Officer.

The Personal Information Card is valid for 5 years. You can expect to receive your card within 10 working days from the date this form is lodged at a Service Tasmania shop.

If you are under 18 years of age your parent or guardian must accompany you to the Service Tasmania shop where this form is lodged. Your parent or guardian will need to:

- provide their current driver licence (or other Category A document listed below) as evidence of their identity, and
- make a declaration as to your identity in front of the Service Tasmania Customer Service Officer.

Evidence of identity – Applicant

You need to show evidence of your identity and evidence of your current residential address.

For evidence of identity you need to show:

- one document from Category A and two from Category B, **OR**
- two from Category A and one from Category B.

If none of the documents used as evidence of identity has your current residential address you must also show a document less than 6 months old from Category C which verifies your current residential address.

All documents must be original (not photocopies). They must be in English or be accompanied by a translation from an accredited translator.

Personal Information Card — Statutory Declaration

▶▶ This Statutory Declaration is **compulsory for ALL applicants** and **MUST** be signed in front of a Service Tasmania Customer Service Officer (CSO).

This is a legal document. Any person who wilfully makes a false statement in the declaration is guilty of a crime under Section 113(1) of the Tasmanian Criminal Code, which can result in a prison sentence. If an applicant is suspected of attempting to obtain a Personal Information Card by providing false information, the matter will be referred to Tasmania Police for investigation. To aid this process, the Tasmanian Motor Registry System may be accessed to check for existing records in an applicant's name.

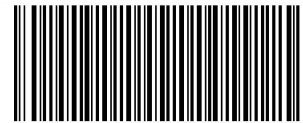

Failure to provide information requested may result in your application not being able to be processed or the service not being able to be provided.

Your personal information will be used for the primary purpose for which it is collected and may be disclosed to contractors and agents of Service Tasmania for this purpose, law enforcement agencies, courts and other organisations authorised to collect it. Your basic personal information may be disclosed to other public sector bodies where necessary for the efficient storage and use of the information. Personal information will be managed in accordance with the *Personal Information Protection Act 2004* (Tasmania) and the *Privacy Act 1988* (Commonwealth) and may be accessed by the individual to whom it relates on request to Service Tasmania. You may be charged a fee for this service.
